

The following quarantined articles require a certificate or permit prior to movement from quarantined area into or through a non-quarantined area:

1. Soil, separately or with other things, except soil samples shipped to approved laboratories.*

- Potting soil is exempt, if commercially prepared, packaged and shipped in original containers.
- 2. Plants with roots with soil attached, except house plants maintained indoors and not for sale.
- 3. Grass sod.
- 4. Baled hay and straw stored in direct contact with soil. **
- 5. Used soil-moving equipment.
- 6. Logs, pulpwood and stumps. ***
- 7. Any other products, articles, or means of conveyance of any character whatsoever not covered by the above, when it is determined by an inspector that they present a hazard of spread of the imported fire ant and the person in possession thereof has been so notified.

* Information as to approved laboratories may be obtained from an inspector.

** Not eligible for movement outside the quarantined area.

*** Exemptions from permit requirements apply for treated railroad loading sites.

Infested area of the City of Lubbock located within Highway 27 to the East, Ursuline Street to the North, Milwaukee Street to the West and 98 Street to the South is quarantined.
